 use for their 146.6100 repeater system. The repeater was purchased around 2001 2003 by a
 grant and is no longer used. Todd Volk, the former Emergency management director has
 advised the county no longer has any ownership interest in the repeater. A motion was made
 by Mike KC9JIK, seconded by Greg W9GDH to donate the repeater to the RCRA. All voted in
 favor.
